**JUSTIFICATION:** This project needs to be added to move the intersection of US16 & Promise Road north to make room for new ramps being constructed as part of the US16 & US16B interchange in FY 2026 (PCN 6874).

**PROPOSED CHANGE:** Add to 2024 as Item #0.10 in SHSUrban Category at a cost of \$4.841; Federal = 3.967, State = 0.874.

**JUSTIFICATION:** The interstate segment was microsurfaced in 2018, however, recent pavement data indentified widespread rutting with readings from 0.4-inch to 0.7-inch in isolated areas. The entire segment is proposed for reconstruction years 2032-2035, in the interim, the pavement needs to be treated as soon as possible to re-address persistant rutting.

**PROPOSED CHANGE:** Add to 2024 as Item #0.11 in IntMaint Category at a cost of \$7.133; Federal = \$6.489; State = \$0.644.
