Eick moved, Gilkerson seconded and motion carried unanimously to approve the minutes from the August 21, 2025 Technical and Citizens Committee meeting.

25TP020 – Approve the 2026 Unified Planning Work Program – Draft Report. The 2026 Unified Planning Work Program (UPWP) includes the annual activities, planning studies, and products to be developed by the Metropolitan Planning Organization for 2026. The Unified Planning Work Program also identifies funding and staffing for conducting these tasks. Brennan reviewed the UPWP and the five studies that were voted



on to pursue for the allocated funding with the UPWP for 2026. Discussion ensued regarding these studies.

Kendall entered the meeting.

Eick moved, Burns seconded and motion carried unanimously to approve the 2026 Unified Planning Work Program – Draft Report along with recommendation that the 2026 UPWP studies include the Regional Signal Optimization Study and the Microtransit Feasibility Study.

25TP020 – Approve the 2025 Rapid City Comprehensive Plan – Draft Report. The Comprehensive Plan serves as the official policy document guiding community development in Rapid City, as well be used to shape the future of our community by reflecting the shared vision of residents. The Comprehensive Plan was developed in conformance with Chapter 11-6 of South Dakota Codified Laws, which regulates the minimum requirements of comprehensive plans. These requirements ensure transparency, community input, and formal adoption procedures in the formation of the Comprehensive Plan. The Comprehensive Plan was made with the purpose of guiding and accomplishing a coordinated, adjusted, and harmonious development of the municipality, which will, in accordance with existing and future needs, best promote health, safety, morals, order, convenience, prosperity or the general welfare, as well as efficiency and economy in the process of development. Kelly Naumann from Logan Simpson presented the key elements of the 2025 Rapid City Comprehensive Plan – Draft Update. Discussion ensued regarding aligning with other Master Plans in other jurisdictions in the area.

Odden moved, Layman seconded and motion carried unanimously to approve the 2025 Rapid City Comprehensive Plan – Draft Report.
