General Public Comment

Dr. Lingwall inquired on the new Liberty Land development and if it will have an impact on the Committee. Harrington advised that it would be listed in the Transportation Improvement Program for Capital Improvements.

Business

23TP034 – Approve the 2024 Transportation Products and Due Dates. Harrington reviewed the 2024 Transportation Products and Due Dates which provides product dates as a workflow guideline for year 2024.

No action was taken on this item.

23TP035 – Approve the Fiscal Year 2023 Annual Listing of Obligated Projects. Each year the Rapid City Area Metropolitan Planning Organization is required to develop the Annual Listing of Obligated Transportation Projects identifying the status of the transportation projects shown in the Transportation Improvement Program for fiscal year 2023. Harrington reviewed this Annual Listing of Obligated Projects. Discussion ensued regarding the update to the listing as well as the projects occurring between Exit 30 and Exit 44.

No action was taken on this item.

23TP038 – Approve the 2024-2027 Transportation Improvement Program Amendment #24-002. Harrington reviewed Amendment #24-002 which adds a project to move the intersection of US Highway 16 and Promise Road, an Interstate Maintenance project to overlay a section of Interstate 90 between Box Elder and New Underwood and a Pavement Preservation project in a number of segments throughout the Rapid City Area. Discussion ensued regarding the Interstate Maintenance Project.

No action was taken on this item.

23TP039 – Approve the 2024-2027 Transportation Improvement Program Amendment #24-001A. This Administrative Amendment adds an emergency structure repair project on the Interstate 190 structure over Interstate 90. Harrington reviewed this amendment. Discussion ensued regarding bridge heights and repairs along Interstate 90.

No action was taken on this item.
