RE: **24TP008 – 2024-2027 Transportation Improvement Program – Amendment #24-003**

Attached for your acknowledgement is Amendment #24-003 to the 2024-2027 Transportation Improvement Program. This amendment adds funding to the Miscellaneous category for a State Transportation Improvement Grant from the Federal Highway Administration. This grant will allow SDDOT to implement an innovative Traveler Communications program in 2024.

Also, the Transportation Commission has selected various Transportation Alternatives projects throughout the state, resulting in the deletion of a funding placeholder in 2024, and the addition of funding for a project to construct sidewalk in Box Elder in 2026
