**19TP018** – Approve the 2020-2023 Rapid City Area Transportation Improvement **Program (TIP)** – Final Report. Brennan reviewed the Rapid City Area TIP final report. This is a four year priority list and financial plan for highway, transit and intermodal projects. The TIP is intended to serve as a fiscal management tool to assist state and local agencies in matching transportation needs with resources. The TIP development, review, and approval process includes participation from affected public agencies, citizens groups, private transportation providers and representatives from various transportation entities.
